#### 8. CHALLENGES REGARDING MOBILITY

In its meeting on 10 December 2004, the Communiqué Drafting Group recognised the need for an in-depth discussion of problems outside the competences of Ministers of Education that restrict mobility (financial, legislative, immigration regulations, etc.), and asked the Secretariat to prepare a document as a basis for discussion in the Board and the BFUG. The discussion document has been further developed on the basis of the deliberations in the Board meeting on 25 January. The BFUG may ask its members to raise the matter nationally before it is raised with the Ministers, cf. agenda item 13.

Proposed action: Decide if the matter should be followed up and raised with the

Ministers in Bergen.

#### 9. APPLICATIONS FOR PARTICIPATION IN THE BOLOGNA PROCESS

By the 31 December 2004 deadline, Armenia, Azerbaijan, Georgia, Kazakhstan, Moldova and Ukraine had applied for participation (membership) in the Bologna Process. All the applications are in accordance with the prescribed procedure. Kazakhstan is not party to the European Cultural Convention and does therefore not meet the criteria for participation. After the deadline, Kosovo has also applied to join the Process in a letter dated 12.01.05.
