Subject: Application for membership to the Bologna Process

Dear Minister:

In the last few years, the European process has become a tangible reality for the European Countries and its citizens. The Republic of Armenia by joining the Council of Europe has stated its commitment to the European Processes and its willingness to undergo all the necessary reforms to become a full-fledged member state. The Ministry of Education and Science of the Republic of Armenia being aware of the crucial role of education and cooperation for strengthening peaceful and stable democratic societies has embarked on the all-encompassing reform process of education and more specifically the reforms of higher education.

Clearly understanding that the Europe of Knowledge is acknowledged as an influential factor for human, social and thus economic development of the societies and being governed by the determination to meet all the requirements of Lisbon Convention and Bologna Declaration and to join the European Higher Education Area, the Draft Law on Higher and Post Graduate Education of the Republic of Armenia has envisioned a central role for the universities, which by assuming the responsibility for quality assurance, respecting the academic freedoms and institutional autonomy with fully developed self-governance, student participation in

the governance of higher education, public responsibility for higher education, assuring the inseparability of teaching and research, affirming the European humanist tradition and supporting a closer cooperation with their counterparts in Europe will come to the doorsteps of belonging to a common social and cultural European space.

Since gaining independence Armenia have made significant steps towards full integration of European structures; most notably with their accession to the Council of Europe. Reform of Education systems has been an important part of this process, to the benefit and credit of Armenia as well as individuals. Education continues to play an important role for sustainable development, since all societies, in particular those in transition, like in Armenia require the participation of informed and well-educated members or citizens in order to build stable democracies based on respect for human rights and the rule of law.

Ministers responsible for Higher Education of South Caucasus stress the wish to join Bologna Process in "Statement of the Ministers of Education of Armenia, Azerbaijan and Georgia", signed in Council of Europe Headquarters, Strasbourg, 17-18 May 2004. They particularly states:

"... Recognizing the importance of the reform of educational system, in particular underlining the necessity to continue the current processes of reform in its national context, the Ministers further emphasise the following priorities:

- Drafting and adoption of new legislation for higher education in line with European norms and standards;
- Reform of the higher education sector in light of the requirements of the Bologna process;
- Continue to support exchange of information and experience between the three Countries in the above-mentioned fields in order to facilitate their countries' integration into common European educational space."

The accession to the European Higher Education Area will significantly promote the improvement of higher education in Armenia and the recognition of Armenian higher education qualifications in Europe.

Taking into account the need to implement the basic principles of accession to the Bologna process in higher education system of Armenia, the following main strategic goals and issues are defined in Strategy of Higher Education, approved by Government of Armenia in 2003:

- To achieve the recognition of Armenia's higher education degrees and qualifications and their comparability with relevant European higher educational Institutions qualifications and diplomas.
- To establish National Information Center on Academic Recognition and Mobility (ENIC)
- To bring into agreement Armenian higher education diploma supplements with the degrees developed in Europe.
- In higher educational institutions introduce a unified credit accumulation and transfer system, which will be compatible with the ECTS.

- · To create favorable conditions and package of legislative amendments for unhindered movement of Armenian students from University to University and for international mobility.
- To join European cooperation programs in the sphere of higher education quality assessment and accreditation
- To develop cooperation with the European Network for Quality Assurance
- To bring the current accreditation criteria and mechanisms into compliance with the European standards established under the European accreditation platform.
- To develop bilateral and multilateral programs between Armenian and European higher educational institutions, common models, courses, and to create majors and joint degrees of higher education qualification.
- To implement curricula refreshment, in order to converge curricula and study plans with the European standards.

Lisbon Convention creates a legal ground for mutual recognition of qualifications for the whole European region. On the other hand, the sample Diploma Supplement developed by the European Commission, Council of Europe and UNESCO creates a mechanism for the recognition and evaluation of individual qualification in foreign countries. Thus the Ministry of Education and Science developed all necessary documents and passed Lisbon Convention to the National Assembly for ratification until the end of this year.

The Ministry of Education and Science of Armenia once again pleased to confirm his adherence to the principles of Bologna Process. On behalf of the Ministry of Education and Science of the Republic of Armenia, I would like to guarantee you of our compliance with the principles of Bologna Process, willingness to pursue and implement the objectives of the Bologna Process in the system of higher education of Armenia.

Honorable Minister, please accept my highest consideration and reassurance of our efforts for further cooperation.





It is a snerial neighbor for me to address Your Excellence on this vitally important occasion for Georgia. I am glad to notice that for the last decade, a number or progressive measures were undertaken within the education system of Georgia and particularly, within the higher education system. Subject: Proclamation of the Republic of Moldova intention to sign the Bologna Declaration.

In the context of the international tendencies towards integration and globalization, the Ministry of Education of the Republic of Moldova highly appreciates the efforts undertaken by EU countries to establish the European Higher Education Area by 2010. The Ministry considers it to be of utmost importance for Moldovan higher education development to achieve the objectives stipulated by the Bologna Declaration.

During the past few years a number of national and international conferences have been organized on the initiative of the Ministry of Education in partnership with Moldovan higher education institutions. Representatives from Council of Europe, experts from UNESCO, EUA and other international organizations have taken part at these conferences and seminars. Discussions and activities have focused mainly on the issues of reconstruction and modernization of the higher educational system of Moldova in compliance with principles and requirements of the Bologna Process.

Our commitment to common European educational values was also expressed at the Conferences of Ministers in Germany, Berlin (September 18-19, 2003), in Greece, Athens (November 11-13, 2003) and at other recent international events such as: UNESCO-CEPES seminar, Ukraine, Kiev (June 13-14).

Last years some structural reforms underwent in Moldova, in order to adjust the system of higher education to the Bologna Process principles. The major objectives of these structural reforms are the following:

- Improvement of the quality of higher education in Moldova;
- Granting of equal opportunities to all citizens who want to obtain higher education;
- Updating of the national curriculum for higher education;
- Quality assurance through the system of accreditation and certification:
- Application of evaluation through the European Credit Transfer System (ECTS);
- Assurance of opportunities for academic mobility;
- Elaboration and introduction of the Diploma Supplement.

During 2004 the Ministry of Education has initiated the elaboration of a new Law of Education and the National Strategy of Higher Education for 2004-2010. The goal of these documents is to adjust the Moldovan system of higher education to the common European standards. For the academic year 2004-2005 it is envisaged to widely adopt the system of higher education based on two cycles, as stipulated by the Bologna Declaration. We are aware of the fact, that adjusting of the national system of higher education to the European standards requires tremendous efforts from all stakeholders of the educational process.

With reference to the above we ask you kindly to view this letter as a statement of our earnest intention to sign the Bologna Declaration. In line with this, by September 2004, the Ministry of Education intends to submit to the Bologna Follow-up Group the Action Plan of reforms, which will be carried out during 2004-2010.

Thereupon, we hope for your assistance and consultations concerning the procedures and the reports that are to be submitted.

We would also appreciate the inclusion of the Republic of Moldova to the events preceding the next Conference of Ministers responsible for Higher Education - Norway 2005.
