





Maastricht University is very pleased to host the first international conference on the European Labour Market for academic graduates:

'Will Higher Education be ready for the European Labour Market?

Competencies, Mobility & Employability after the Sorbonne-Bologna Proces'.

(ELM 2006), from October 19 to October 21, 2006.

The Bologna process seems well on its way. Despite the many matters that still have to be resolved, higher education institutions and agencies are working towards the objectives of Bologna: increased mobility, a better quality of and more transparency in higher education.

However, less is known about the effects of the changes that are made. Will the European graduates of the future be working abroad, or just re-invest their international experience in their own region?
Will the selection criteria of recruiters change?
How will they value international experience?
It is likely that the Bologna objectives will become intertwined with phenomena like quality of networks, competition, competencies and selectivity. As a result, the Bologna process, and the re-launched Lisbon Strategy, would not only generate European graduates, but also significantly change the roles of recruiters, academic staff and governments.
The question is: to what extent, and at which speed?

At this conference, several options, best practices and outcomes from recently completed research will be discussed.
